This data includes contact details, Early Years Foundation Stage assessments, eligibility for Early Years Pupil Premium (EYPP), 2 year old funding or funding for 3 and 4 year olds, attendance information, sessions attended, characteristics such as ethnic group, special educational/developmental needs and any relevant medical information.

We will not give information about your child to anyone outside the early years setting without your consent unless the law and our rules allow us to.

From time to time the setting is required by law to pass on some of this data to the local authority (Southend on Sea Borough Council). The information we collect will be stored either in locked storage or electronically with password protection, encryption and restricted access. All data will be transferred either through a secure website or by secure email. They in turn are required to pass some data on to the Department for Education (DfE). These are data controllers in respect of the data they receive, and are subject to the same legal constraints in how they deal with the data. This data may only be used or passed on for specific purposes allowed by law. The information provided by you will be held and processed by Southend on Sea Borough Council in accordance with the Data Protection Act 1998. It will be used for its intended purpose but may also be used for internal statistical analysis as well as being processed and disclosed for the prevention or detection of crime or assessment of tax. The local authority may also need to share your information with a third party such as a contractor, in order for them to assist in providing service. However, the Council requires any third parties to abide by the law when they process your data on their behalf and to follow their procedures or instructions. You have the right to opt-out of your information being shared this way. If you wish to opt-out please contact the Group Manager for Early Years at <u>earlyyears@southend.gov.uk</u> who will acknowledge your request in writing. The information obtained will be retained in accordance with the requirements of the Council's Document Retention and Disposal Guidance and when no longer needed, it will be deleted securely. You are entitled to copies of any information that the Council holds about you. This can be obtained by making a request in writing by using a Subject Access Request form. There may be situations where you find that information we hold is no longer accurate and you have the right to have this corrected, or, under certain circumstances deleted.
